

CAMPING RULES AND INFORMATION

Thank you for staying with us here at The Island ASC. Below are our rules and information that is implemented to provide an enjoyable and safe place for you, your family and friends to camp. We ask all patrons to adhere to our rules, and respect one another, the residents and the property.

More information and maps will be provided upon your arrival. Failure to comply with our rules leaves us no choice but to ask you to leave, and a 12-month suspension for camping and riding will be enforced.

NOISE

All Campers to respect all other campers. No noise or music between 9pm - 7.30am.

GENERATORS AND POWER SUPPLY

All Generators and noise ceases by 9.00pm. The Island ASC is totally off grid power supply, therefore, please limit use of power when required.

FIRES/WOOD/COOKING

Fires for cooking only.

Fires are permitted outside the Bush Fire Danger Period. However, they MUST be situated in an elevated fire pit (at least 400mm above the ground). We do not allow fires on ground level. This includes open cooking fires. Gas cooking is permitted. Please bring your own firewood and please take home any leftover firewood. No larger fires other than the community firepit.

NO ALCOHOL PERMITTED

No alcoholic beverages allowed at the complex. The Island ASC is an Alcohol-free zone. If alcohol is seen, you will be asked to leave immediately.

NO VEHICLE MOVEMENTS AFTER 4PM

The camping ground gate and highway gate close at 4.30pm.

RIDING AND BIKES

Riding hours are between 8.00am - 3.30pm. No bikes after 4.00pm (this includes maintenance). If staff or residents hear bikes you will be asked to leave The Island ASC immediately.

VEHICLES AND FOOT MOVEMENT

No vehicles movements after 4.30pm. Campers are NOT permitted to leave the camping area by car or foot. You MUST stay within the designated camping area, unless you are using the amenities. Any persons found outside the grounds will be asked to leave immediately.

SECURITY

The Island ASC accepts no responsibility for loss and damage to your property.

PLEASE ABIDE BY SIGNPOSTS

All speed and slow zones are sign posted.

NO GUESTS

No guests at camp site. Only registered and booked patrons.

NO GLASS IS PERMITTED AT THE COMPLEX. NO FIREARMS, FIREWORKS OR CHAINSAWS.

MOBILE SERVICE COVERAGE

Optus is good. Telstra can be limited.

NO PETS

Pets are NOT allowed at The Island ASC. If pets are seen or heard, you will be asked to leave. Guide dogs exempt.

NO INTERACTION WITH WILDLIFE or CATTLE

Please respect the wildlife on our property. No interaction or harassment of our resident kangaroos, wildlife, or cattle.

MEDICAL SERVICES

The Island ASC has paramedics on site for the duration of riding hours, however in the case of an afterhours emergency, please dial 000. The nearest hospital is Richmond St, <u>Bulahdelah</u> PH: 02 49879900.

DO NO ENTER

Do not enter any buildings unless authorized by management or staff to do so.

AMENTIES

Please be advised we are only on tank water. Limit showers to a few minutes, otherwise we will run out of water. Once we are out, we are out!

PLEASE NOTE WE DO NOT HAVE ANY TOLERANCE FOR DISORDERLY AND DISRESPCTFUL BEHAVIOUR.

LEAVE CAMPING GROUND CLEAN.

PLEASE TAKE YOUR RUBBISH WITH YOU. DO NOT LEAVE FOOD AROUND AS WILDLIFE WILL COME INTO THE CAMP AREA.

CHECK-IN CHECK-OUT

If you're riding on the **SATURDAY ONLY**, please check-out at the office by 8am Sunday. If you're riding on the **SUNDAY ONLY**, please check-in at the office no later than 3pm Saturday. If riding both days – regular hours (7:30am – 4pm).
